Title: Company Physiotherapist

# **Summary of role:**

To assist in providing an effective physiotherapy service, primarily for the BRB company dancers, but also for the other members of the company and Sinfonia as appropriate.

## **KEY RESPONSIBILITIES:**

# I Clinical/Medical

- 1. Assess injured dancers/company members, and provide appropriate treatment and rehabilitation at the Jerwood Centre and on tour
- 2. Provide health care service provision on tour nationally and internationally including liaising with other members of Jerwood Centre staff and ballet staff, including the Company Manager
- 3. Deliver rehabilitation of dancers where appropriate
- 4. Participate in screening of all new and post-injury dancers and advise Head Physiotherapist and Clinical Director of any concerns regarding ability of dances to perform
- 5. Recommend to the Head Physiotherapist and Clinical Director referrals for investigations or to other health professionals.
- 6. Advise the Head Physiotherapist and Clinical Director on fitness of dancers to participate in company class, rehearsals and performances.
- 7. Attend BRB and Jerwood team meetings as requested.
- 8. Collaborate closely with all other members of the team including the ballet staff on all patients receiving care but in particular those dancers under the Progression Plan
- 9. Advise Head Physiotherapist and Clinical Director of any worries regarding the general physical and psychological well-being of the company dancers and other members of BRB as appropriate.
- 10. Deputise for the Head Physiotherapist in his/her absence within agreed limits of authority.

### II Administration

- Keep clear records and notes in accordance with the guidelines set down by CSP, and Data Protection guidelines using BRBs Electronic Medical Notes System.
- 2. Complete injury evaluation documentation as per of the on-going injury audit
- 3. If required, pack equipment required for UK and overseas tours.

# III Health & Safety:

- 1. Follow guidance given by Clinical Director regarding appropriate responsibilities under Health & Safety regulations.
- 2. Report any Health & Safety concerns to the Clinical Director.
- 3. Provide first aid advice for company members while in Birmingham and on tour, and assist in development of first-aid training across the organisation. (NB: the holder of this position must have an up-to-date first aid certificate.
- 4. Participate in teaching health/injury prevention/ergonomics to other departments when requested.

## **IV** Development:

- 1. Maintain contacts with other physiotherapists working with dance-related injuries in order to share information and increase understanding and awareness of dance-related injuries.
- 2. Continue to develop physiotherapy skills by attending appropriate courses, subject to funding and approval by Human Resources Director.
- 3. Attend and participate in the in-service educational programme as part of the CPD of the Jerwood Team
- 4. Contribute to research initiatives as directed by the Clinical Director.

### V General

1. Work within the rules, regulations and ethics of The Chartered Society of Physiotherapy.
